CLASS "C" – STERLING DISTRIBUTING SHARES (ISIN:IE00B2PKN434) PRUSIK ASIAN SMALLER COMPANIES FUND PLC ("THE FUND")

Objectives and Investment Policy

- The Fund aims to preserve capital and generate returns. It will invest in listed equities in the Asia Pacific region excluding Japan who have smaller market values, whilst maintaining a level of volatility significantly below what prevails for other similar investment strategies in the market.
- The Fund is not restricted by the market value of the stocks it invests in. Its investments will typically be diversified but the Fund may focus on particular industries, geographical areas, or types of securities and issuers from time to time.
- The Fund uses cash and invests in derivative instruments (including but not limited to futures, options, swaps, warrants and forward currency contracts) when there are few opportunities in the market, its capital is at risk, and in order to reduce volatility. The derivatives return is linked to movements in the underlying asset.
- The Fund can also invest in shares issued outside of

Asia and Australasia and in debt and other fixed income securities of Asian and Australasian and other issuers.

- The Fund will from time to time use investment techniques known as 'hedging' to provide protection against exchange risks for the efficient management of its investments.
- You can buy or sell your shares every Friday that is a business day (in Dublin), by giving notice of 2 business days. The Fund allows dividends to be paid out or accumulated within the Fund if they are declared.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.


